FOURTH: The merger is to become effective on July 31, 2018.

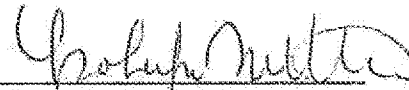
FIFTH: The Agreement of Merger is on file at 8500 Balboa Boulevard, Northridge, CA, 91329, the place of business of the surviving corporation.
