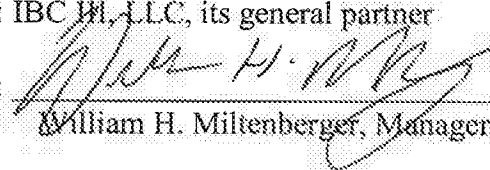
1. This Release of Security Interest (this "Release") is effective August 30, 2019.

Each of IBCF and DSV, without representation, warranty or recourse, releases and terminates all security interests and other rights granted or pledged in all "Collateral" identified in each agreement listed below, including, without limitation, any inventions, patents, patent applications, trademarks, trademark registrations, works, copyrights, and copyright registrations, including, without limitation, the properties identified in Attachments A, B, and C of this Release, and including without limitation all rights and security interests in any proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all renewals and extensions thereof, which security interests and other rights were granted under any and all of the following agreements:
 - A. the Note Purchase Agreement, dated as of December 31, 2018, by and among General Technologies, Inc., a Texas corporation ("GTI"), Fincorp Leasing, L.P., a Texas limited partnership ("Fincorp"), Trinity Freeport Holdings, L.P., a Texas limited partnership ("Trinity"), GTI Holdings, LLC, a Texas limited liability company, Precision-Hayes International, Inc., a Delaware corporation ("PHI"), IBCF, and DSV;
 - B. the Patent Security Agreement, made and effective as December 31, 2018, by Felix Sorkin, a Texas resident ("Sorkin"), in favor of IBCF and DSV;
 - C. the Security Agreement, dated as of December 31, 2018, by GTI, Fincorp, Trinity, Holdings, IBCF, and DSV; and

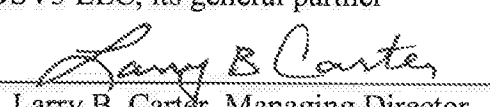
