AND, TME HEREBY further covenants and agrees that it will, through its officers and employees, without further consideration, communicate with TJJK, its successors and assigns, any facts known to it and its officers and employees regarding U.S. Patent No. 10,223,655, and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to U.S. Patent No. 10,223,655, execute all reissue applications, make all rightful oaths and generally do everything possible to aid TJJK, its successors and assigns, to enforce U.S. Patent No. 10,223,655 in the United States, it being understood that any expense incident to the execution of such papers shall be borne by TJJK, its successors and assigns.
