Assignment

WHEREAS, I, Robert Wayne Hobson, have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Power Cable System With Cooling Capability**, bearing US Patent Application No. 16/506,643 and filed on July 9, 2019;

1. Assign, transfer and convey to Assignee the entire right, title and interest in and to the inventions and discoveries set forth in an application for Letters Patent of the United States of America, entitled **Power Cable System With Cooling Capability**, bearing US Patent Application No. 16/506,643 and filed on July 9, 2019, (hereinafter "said inventions and discoveries" and hereinafter "said application for Letters Patent of the United States of America"), any and all other applications for Letters Patent on said inventions and discoveries in any or all countries, including all divisional, renewal, substitute, continuation and convention applications based in whole or in part upon said inventions or discoveries, or upon said applications, and any and all Letters Patent, reissues and extensions of Letters Patent granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent;

2. Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in my name or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;

3. Authorize and request the Commissioner for Patents of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patents to Assignee, as assignee of the entire right, title and interest therein or otherwise as Assignee may direct;

4. Warrant that I have not knowingly conveyed to others any right in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that I have good right to assign the same to Assignee without encumbrance;

5. Bind my heirs, legal representatives and assigns, as well as myself, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to me or them, all acts reasonably serving to assure that said inventions and discoveries, said patent applications and said Letters Patent shall be held and enjoyed by Assignee as fully and entirely as the same could have been held and enjoyed by me, my heirs, legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to Assignee all lawful application documents, including petitions,

specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignee; to communicate to Assignee all facts known to me relating to said inventions and discoveries or the history thereof; and to furnish Assignee with any and all documents, photographs, models, samples and other physical exhibits in my control or in the control of my heirs, legal representatives or assigns, which may be useful for establishing the facts of my conceptions, disclosures, and reduction to practice of said inventions and discoveries.

6. This agreement shall be governed by the laws of the State of North Carolina and any disputes regarding this agreement shall take place in a court of competent jurisdiction within the State of North Carolina.
