WHEREAS, ASSIGNOR is the applicant of the U.S. Patent Application No. **16/375,185**, filed 4/4/2019 for a **Urine Neutralization and Conversion System and Method** (the PATENT) and entitled and any and all applications for patent and patents granted therefor in any and all countries, including all divisions, reissues, continuations, reexaminations, inventor's certificates, and extensions therefor, and all right of priority resulting from the filing of said U.S. patent application.

WHEREAS, ASSIGNOR is the applicant of the trademark application **ScentRelief**, U.S. Ser. No. **88/564,620**, ("the MARK") together with the goodwill of the business symbolized thereby in connection with the goods with which the MARK is used.

NOW, THEREFORE, in consideration for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of the ASSIGNOR'S right, title and interest of whatever kind in the PATENT, the MARK, and the goods and assets with which the MARK is used, specifically including related UPC registrations, together with (1) the goodwill of the business relating to the goods in respect upon which the MARK is used and for which it is registered; (2) all income, royalties, and damages hereafter due of payable to ASSIGNOR with respect to the MARK and the PATENT, including without limitation, damages and payments for past or future infringements and misappropriations of the MARK or the PATENT; (3) all rights to sue for past, present, and future infringements or misappropriations of the MARK or infringement of the PATENT; and (4) any and all applications for patent and patents granted therefor in any and all countries, including all divisions, reissues, continuations, reexaminations, inventor's certificates, and extensions therefor, and all right of priority resulting from the filing of the PATENT.

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the PATENT, the MARK, and in the goods in respect upon which the MARK is used and for which it is to be registered.
