We represent and warrant that we have full right to agree to, execute, and deliver this assignment, and that we have not made any agreement in conflict with this assignment. We agree that we will without further consideration, but at the expense of Assignee, communicate to said Assignee, or its successors, assigns, or nominees, any and all facts known to us regarding said inventions whenever requested, and that we will execute all non-provisional, divisional, reissue, continuation and continuation-in-part applications, testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything reasonable for said Assignee, its successors, assigns, and nominees, to obtain and enforce proper patent protection for said inventions in all countries.
