 the United States and its territorial possessions;


NOW, THEREFORE, the Assignor agrees as follows:

ASSIGNOR further authorizes and requests the Commissioner of Patents and Trademarks to issue the above indicated percentages of any and all Letters Patent referred to above to each ASSIGNEE, as the ASSIGNEE of the partial right, title and interest in and to the same, for ASSIGNEE's sole use and behoof; and for the use and behoof of each ASSIGNEE's legal representatives and successors, to the full end of the term for which such Letters Patents may be granted, as fully and entirely as the same would have been held by ASSIGNOR had this assignment and sale not been made.
