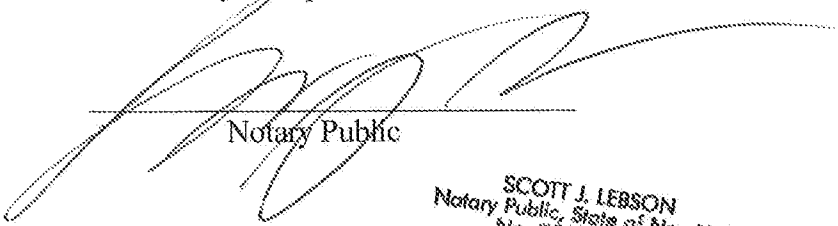

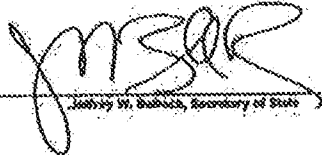

Pursuant to Section 252 of the Delaware General Corporation Law ("the DGCL"), each of the undersigned on behalf of the constituent corporations named herein

DOES HEREBY CERTIFY:

FIRST: That Irwin Industrial Tool Company, a Delaware corporation, and Black & Decker (U.S.) Inc., a Maryland corporation, agree to merge.

SECOND: That the name of the surviving corporation of the merger is Black & Decker (U.S.) Inc., a Maryland corporation.

THIRD: That the terms set out in the Agreement and Plan of Merger have been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 252 of the General Corporation Law of the State of Delaware and the General Corporation Law of the State of Maryland.

FOURTH: The Agreement and Plan of Merger is on file at 701 East Joppa Road, Towson, Maryland, the place of business of the surviving corporation.

FIFTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.

SEVENTH: The surviving corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of any constituent corporation of Delaware, as well as the enforcement of any obligation of the surviving corporation arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the DGCL, and irrevocably appoints the Secretary of State of Delaware as its agent to accept services of process in any such suit or proceeding. The Secretary of State shall mail a copy of any such process to the surviving corporation at Black & Decker (U.S.) Inc., 701 East Joppa Road, Towson, Maryland, 21286.

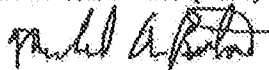
EIGHTH: That this Certificate of Merger shall be effective on December 29, 2018.
