## ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

- (c) all other intellectual property rights relating to the Works, including, but not limited to trade secrets, know how, patents, design patents, designs and applications therefore and improvements in respect thereof;
- (d) all concepts, reports, information, data, computer programs and other ideas and materials developed, invented, prepared or discovered by Assignor or any of its employees, agents or contractors alone or in collaboration with others, which relate to the Works or the actual or anticipated activities, business, or research of Assignee which results from or is suggested by work performed by Assignor ("Developments") and any trade secret, copyright patent, common law right, or any other proprietary right in such Developments.

Assignor hereby assigns to Assignee its entire current and any future right, title and interest in the intellectual property in the Works and Developments identified in Sections (a) - (d) above (collectively, the "Intellectual Property") and Assignee alone has the right to obtain and hold in its own name, copyrights, patents, design patents and such other protection as may be appropriate to the subject matter of the Intellectual Property and derivative works relating thereto.

Assignor agrees to give Assignee such reasonable assistance at Assignee's expense as may be required to perfect and protect the Intellectual Property rights assigned hereunder and to execute at the request of Assignee all documents necessary to convey and confirm in Assignee all rights in the Intellectual Property in respect of the Works, Developments and derivative works and other rights conveyed herein.

Assignor agrees that he or she has the full right to convey the entire interest herein assigned, and that he or she has not executed, and will not execute, any agreement in conflict herewith.

This Assignment and the exhibits hereto constitute the entire understanding and agreement of the parties with respect to the subject matter hereof and supersede any and all written or oral, prior or contemporaneous understandings and agreements. This Assignment may only be amended by written agreement of the parties. This Assignment shall be binding upon the parties, their heirs, successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.

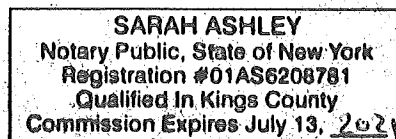
