This assignment embodies the entire understanding of **ASSIGNOR** and **ASSIGNEE** and supersedes and replaces any and all pre-existing assignments or understandings between **ASSIGNOR** and **ASSIGNEE**. No amendment or modification of this assignment shall be valid or binding upon **ASSIGNOR** or **ASSIGNEE** unless made in writing and signed on behalf of each of **ASSIGNOR** and **ASSIGNEE** by their respective duly authorized representative.

ASSIGNOR HEREBY GRANTS to the law firm of **Stetina Brunda Garred & Brucker** the power and authority to insert in this Assignment any further identification which may be necessary or desirable to comply with the rules of the U.S. Patent and Trademark Office and any rules of any country or countries foreign to the United States for recordation. ASSIGNOR hereby further authorizes and requests ASSIGNEE's attorney to insert or correct above the relevant application number(s) and filing date(s) of said application(s) when known.
