
**PATENT ASSIGNMENT**

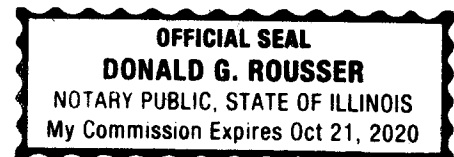
