DEED OF ASSIGNMENT OF PATENT

DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT (hereinafter referred to as "Agreement") is made and entered into this NOV 27 2011 by and between:

1. Wendell G. Mendoza, Rita Josefina M. Santos, Kennie U. Dee, all of legal age, with office and postal address at 66 United Street, Mandaluyong City, 1550 Philippines, (hereinafter collectively referred to as "Assignors");

AND

2. Novex Science PTE. Limited, a corporation duly organized and existing under the laws of Singapore with Company Registration No.:201633285N and having its registered office at 152 Bench Road, #10-04, Gateway East, Singapore 189721, represented by its Director, Kennie U Dee (hereinafter referred to as "Assignee");

WHEREAS

- A. The Assignors are the owner of the patent particularly described in Schedule "A" of this Agreement (hereinafter collectively referred to as the "Patent"). For the purposes of this Agreement, Patent shall mean all patent and patent application identified in Schedule "A" and any future patent and patent application, which is/are based upon or derive from the said patent identified in Schedule "A";
- B. The Assignee desires to acquire and the Assignors desire to assign all their rights, title, interests and participation of the Assignors in the Patent to Assignee in accordance with the terms and conditions hereinafter set forth;

NOW THEREFORE, that in consideration of, among other things, the mutual promises contained in this Agreement, the parties agreed:

1. For valuable consideration, the Assignors hereby assign to the Assignee their entire right, title property and interest in and to the Patent (including but not limited to the right to take action in respect of any past or existing infringement of the Patent and to claim damages or conversion or otherwise in respect of any infringement or right to license the Patent to any party) together with the whole of the goodwill of the business concerned in the goods and products' for which the Patent are used and registered to hold the same unto and to the Assignee absolutely.
2. The Assignee undertakes to maintain the validity and pay all dues and annuity fees for the continuing validity and subsistence of the Patent.
3. The Assignors shall at the request and expense of the Assignee execute and do all acts and things as may be necessary or proper to confirm and record the assignment of the rights referred to in Clause 1 and to perfect and evidence the proprietorship of the Assignee therein.
4. Pending recordal of the Assignee as the registered proprietor of the Patents, the Assignors agree to render such assistance as the Assignee may reasonably request including but not limited to the permission to use the Assignors' name in any proceedings in which the subsistence, ownership or infringement of any of the Patent is disputed, and the Assignee hereby agrees to indemnify the Assignors for all cost and other liabilities incurred by the Assignors out of such proceedings.

5. The Assignors covenant with the Assignee that it has done or knowingly suffered or been a party or privy to any act or thing whereby it is prevented from validity assigning the rights referred to in Clause 1.
6. In this Agreement, the expressions "Assignors" and "Assignee" shall, where the context so admits, include their respective successors and assigns.
7. The Parties represent that they are duly authorized to enter, sign, execute and deliver this Agreement and for this purpose, shall submit the appropriate resolutions and authorities upon the execution of this Agreement. The parties undertake to provide, execute, deliver and expedite the processing and submission of any document which may be necessary or required to give effect to this Agreement.
8. This Agreement contains the entire agreement between the parties hereto with respect to the agreement and the transactions contemplated herein. All prior understandings and agreements shall be considered superseded and/or merged herein.
9. This Agreement shall be governed by and construed in accordance with the laws of the Philippines and the parties hereby agree to submit to the exclusive jurisdiction of the courts of Mandaluyong City, Philippines.


