CONFIRMATORY ASSIGNMENT

THIS CONFIRMATORY ASSIGNMENT, made this 30 day of August, 2019, by and between Matthew P. Klein (hereinafter referred to as "Assignor"), residing at 7055 Randall Drive, Fenton, Michigan 48430, and Plascon Packaging, Inc. The Confirmatory Assignment is intended to confirm the prior assignment of the Patents and Patent Applications listed in *Schedule A*; and the Parties further acknowledge and agree:

WHEREAS, PLASCON PACKAGING, INC., also referred to as "Plascon Group," a corporation organized under and pursuant to the laws of the State of Michigan having its principal place of business at 2375 Traversefield Dr., Traverse City, MI 49684 (hereinafter referred to as "Assignee"), is desirous of acquiring and/or confirming the right, title and interest in, to and under said Patents and Patent Applications listed in *Schedule A* and the invention covered thereby;

WHEREAS, Assignor entered into an agreement with Plascon, Inc., Plasport, Inc., Plascon Packaging, Inc. and Plascon Films, Inc., which was dated March 12, 2012 (the "2012 Plascon Agreement"). Under the 2012 Plascon Agreement, Assignor signed an assignment dated October 30, 2014 (the "2014 Assignment") which collectively transferred all of his entire right, title and interest in said Patents and Patent Applications, which Assignor confirms herein that he has previously assigned all rights in the Patents and Patent Applications listed in *Schedule A*, and hereby assigns any remaining rights to the extent any exists;

WHEREAS, Plascon Inc. and Assignor entered into a royalty agreement in October of 2015 that was amended in May of 2017 ("Royalty Agreement");

WHEREAS, Plascon Packaging, Inc. acknowledges and agrees that under the Royalty Agreement that Plascon Inc. may assign it and the rights and obligations under the Royalty Agreement and the parties therein remain obligated to perform under the Royalty Agreement; and


WHEREAS, Plascon Packaging, Inc. further agrees this Confirmatory Assignment shall not extinguish or alter in any way the Royalty Agreement and payments to Assignor under the Royalty Agreement.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the said Assignor confirms he executed the 2012 Plascon Agreement, which included his agreement to assign all of his rights to the Patents and Patent Application and such assignment extended to or has since been assigned to Plascon Packaging, Inc. per the terms of the Parties' agreements described herein, including the right to sue and collect for any past and/or future infringements thereof, for the United States of America and all other countries in and to said Patents and Patent Application for all original, divisional, continuation, continuation-in-part, substitute or reissue applications and patents applied for or granted therefore in the United States of America and all other countries on the attached list of *Schedule A*;

Assignor further confirms the Commissioner of Patents and Trademarks is hereby authorized and requested to issue all patents on *Schedule A* to said assignee herein, as assignee of the entire interest therein; and the undersigned for itself and its legal representatives, heirs and assigns does hereby agree and covenant without further remuneration, to execute and deliver all divisional, continuation, continuation-in-part, reissue and other applications for Letters Patent and all assignments thereof to said assignee or its assigns, to communicate to said assignee or its representatives all facts known to the undersigned respecting said invention listed on *Schedule A* whenever requested, to testify in any interferences or other legal proceedings in which said application or patent may become involved, to sign all lawful papers, make all rightful oaths, and do generally everything necessary to aid assignee, its successors, assigns and nominees to obtain patent protection for said invention listed on *Schedule A* in the United States of America and all other countries, the reasonable expenses incident to said application listed on *Schedule A* to be borne and paid by said Assignee; and

Assignor further hereby assigns to Assignee, to the extent any rights exist, any and all remaining rights in the Patents and Patent Applications listed in *Schedule A*
