WHEREAS, pursuant to the Security Agreement and the Patent Security Agreements, each Assignee pledged and granted to the Assignor a continuing security interest in and lien on such Assignee’s right, title and interest in and to all Patent Collateral owned by such Assignee, including, without limitation, the items set forth on Schedule 2 hereto;

WHEREAS, the Assignees desire that the Assignor terminate and release its continuing security interest in and lien on the Assignee’s right, title, and interest in and to the Patent Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Release of Security Interest in Patent Collateral. The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its continuing security interest in and continuing lien on the Assignees’ right, title and interest in and to the Patent Collateral and all Proceeds and products of any and all of such Patent Collateral and all collateral security and guarantees given by any Person with respect thereto, and reassigns and transfers to the Assignees all right, title and interest that the Assignor may have in the Patent Collateral, such Proceeds and such collateral security and guarantees.

SECTION 2. Termination. The Assignor hereby terminates and cancels the Patent Security Agreements.

SECTION 3. Recordation of Release. The Assignor hereby authorizes the Assignees, or the Assignees’ authorized representative or representatives, as the case may be, to record this


