An undivided interest in and to Patent #7,267,602, registered with the United States Patent and Trademark Office ("USPTO");


An undivided interest in and to Patent #7,207,870, registered with the USPTO;

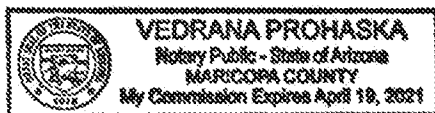


