

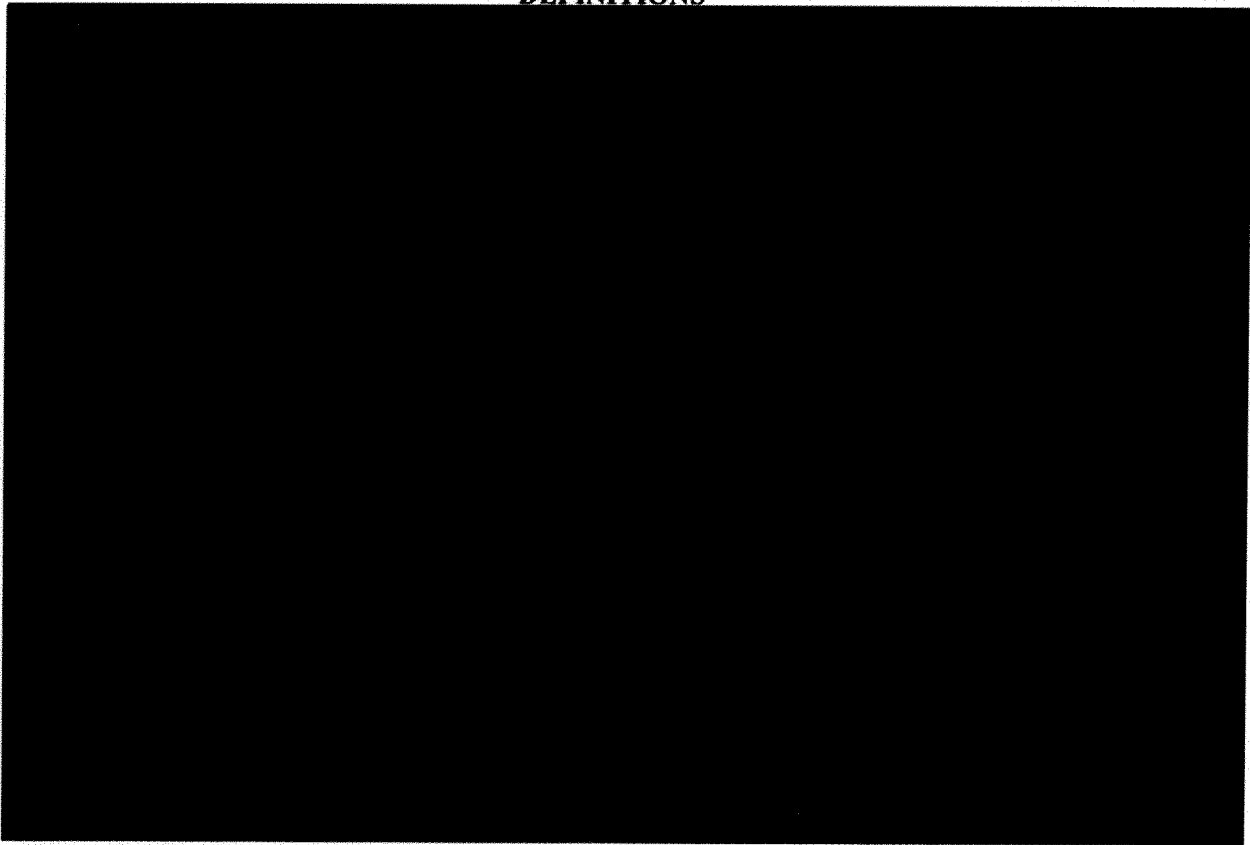

RECITALS

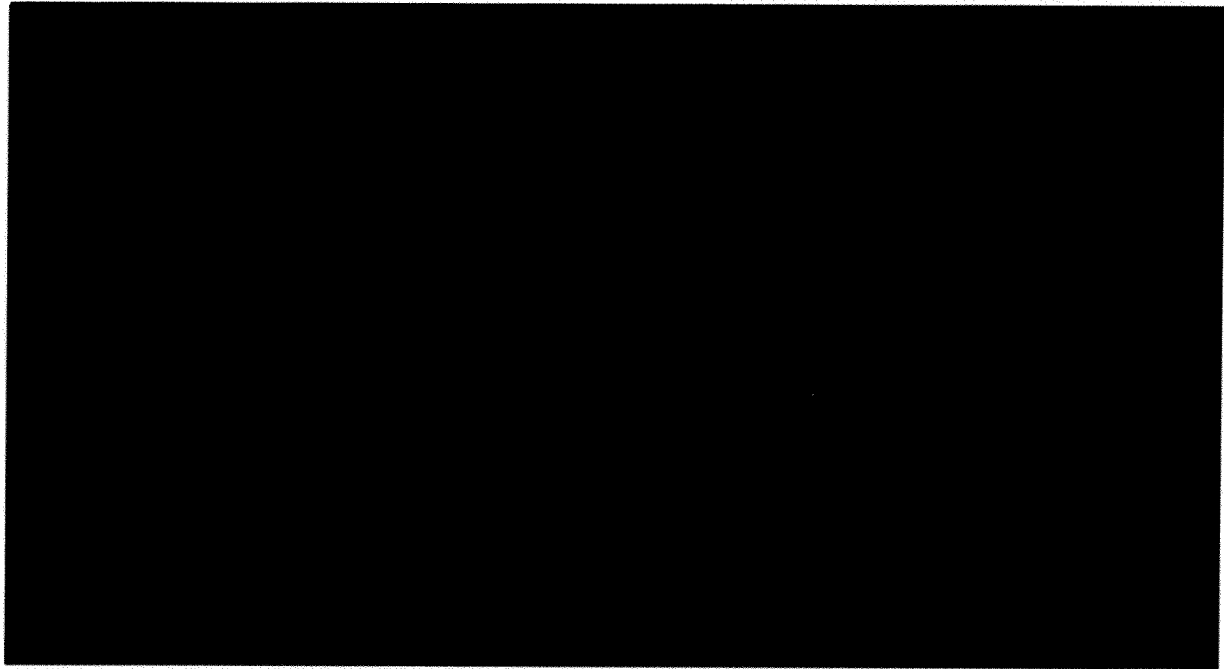
- A. The Member has formed the Company for the purposes described in this Agreement.
