Röhm GmbH & Co. KG was formally registered with the local Court of Darmstadt – Commercial Register - under registration number HRA 6739, having its registered office in Darmstadt and changed its name to Röhm GmbH by resolution on the change of legal form of March 1, 2006.
Röhm GmbH was registered with the local Court of Darmstadt – Commercial Register - under registration number HRB 85142 on June 7, 2006.
An entry referring to the former Röhm GmbH & Co. KG was also made at the same time. Röhm GmbH, having its registered office in Darmstadt, is the unrestricted legal successor of the former Röhm GmbH & Co. KG.
