ASSIGNMENT

WHEREAS, I, **Jia Zhang**, a resident of Irvine, California, **Christopher Nguyen**, a resident of Huntington Beach, California, **Marianne Kodimer**, a resident of Huntington Beach, California, and **Brendon Wai**, a resident of Lake Forest, California (hereinafter referred to as "ASSIGNORS"), have invented **ASSET MANAGEMENT FRAMEWORK FOR CUSTOMIZING MULTIFUNCTION PERIPHERAL CONFIGURATIONS**.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, said ASSIGNORS, hereby sell, assign, and transfer and set over, unto said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under said invention, and said United States provisional application and all nonprovisionals, divisions, renewals, and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues, reexaminations and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals, reexaminations and reissues thereof.


