PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT (this "Release") is made as of September 30, 2019, by SUNTRUST BANK, in its capacity as Administrative Agent ("Administrative Agent") for the benefit of the Secured Parties (as defined in the Security Agreement, defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, HFN, LLC, an Illinois limited liability company (f/k/a HFN, Inc.) ("Grantor"), and Administrative Agent are parties to that certain Patent Security Agreement dated as of June 30, 2015 (the "Security Agreement") pursuant to which Grantor granted to Administrative Agent a security interest in certain Patent Collateral as security for certain obligations owing by Grantor to Administrative Agent, including the Patent Collateral set forth on Schedule I hereto;

WHEREAS, the Security Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on June 30, 2015, at Reel 035987, Frame 0308; and

WHEREAS, Grantor has requested that Administrative Agent, and Administrative Agent now desires to, terminate and release its lien on and security interest in the Patent Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent, on behalf of itself and the Secured Parties, hereby automatically and unconditionally terminates the Security Agreement, and discharges, releases, cancels and terminates its lien on and security interest in all of Grantor's right, title and interest in and to the Patent Collateral granted pursuant to the Security Agreement, including the Patent Collateral set forth on Schedule I hereto.
2. Administrative Agent, on behalf of itself and the Secured Parties, hereby fully reassigns, grants and conveys to Grantor, any and all of Administrative Agent's right, title and interest in and to the Patent Collateral.
3. This Release shall be governed by the internal laws of the State of New York.
4. Administrative Agent hereby authorizes and requests the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
