I, as ASSIGNOR, hereby represent and warrant that I have not granted any right, title or interest that would be inconsistent with the right, title and interest granted herein.

I, as ASSIGNOR, hereby authorize ASSIGNEE and its legal representatives to apply for foreign patents based on said invention or on said application(s), in ASSIGNEE'S own name or through its successors, assigns, designees, legal representatives, subsidiaries or related companies, under an international Convention or otherwise, and to enter into the appropriate spaces above in this ASSIGNMENT document, the filing date and USPTO Serial Number of said application for United States Patent, when known.

I, as ASSIGNOR, hereby authorize and request the Commissioner of Patents (or the equivalent) in any organizations or countries foreign to the United States of America to issue any said foreign patent(s) to ASSIGNEE of the entire right, title and interest in and to any of said foreign patent application(s) or foreign patent(s) for the sole use and behoof of ASSIGNEE to the full ends of the respective terms for which said patent is granted.

This ASSIGNMENT is governed by and is to be construed in accordance with the laws of the State of Ohio, U.S.A. No representations, warranties, collateral assignments or conditions affecting this ASSIGNMENT are valid other than those expressed in this ASSIGNMENT. ASSIGNOR agrees that the provisions of this ASSIGNMENT are fully binding on ASSIGNOR and that ASSIGNOR'S respective heirs, executors, assigns and administrators have no right, title or interest in any of said applications, inventions or patents whatsoever.

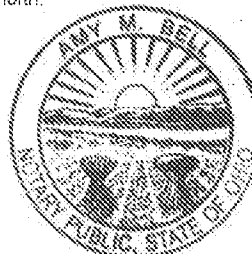
