I, as ASSIGNOR, hereby represent and warrant that I have not granted any right, title or interest that would be inconsistent with the right, title and interest granted herein.

I, as ASSIGNOR, hereby authorize and request the Commissioner of Patents (or the equivalent) in any organizations or countries foreign to the United States of America to issue any said foreign patent(s) to ASSIGNEE of the entire right, title and interest in and to any of said foreign patent application(s) or foreign patent(s) for the sole use and behalf of ASSIGNEE to the full ends of the respective terms for which said patent is granted.

This ASSIGNMENT is governed by and is to be construed in accordance with the laws of the State of Ohio, U.S.A.
