Korean Patent Application No. 10-2017-0105551, filed on August 21, 2017, which applications are collectively referred to as "the patent applications."



oaths, and do everything possible to aid **KOREA RESEARCH INSTITUTE OF CHEMICAL TECHNOLOGY**, its successors, and assigns to obtain and enforce proper patent protection for said invention in the United States or any foreign country.
