PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT (the "Assignment") is effective as of 17, June 2019 (the "Effective Date"), by and between Mark E. Ridall, an individual residing at 2 Woodlawn Lane Pennington, NJ 08534 (hereinafter the "Assignor"), and NewMarket Pharmaceuticals LLC, having a place of business at 4 Pitcairn Avenue, Suite 4, Trenton, NJ 08628 (hereinafter the "Assignee").

WHEREAS, Assignee desires to acquire from Assignor, and Assignor desires to transfer to Assignee, rights to certain patents held by Assignor;

WHEREAS, Assignor is the sole and exclusive owner of certain United States and/or foreign patents and/or patent applications listed in Schedule A below collectively referred to as the "Patents");

NOW, THEREFORE, in consideration of the mutual agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby sells, assigns, transfers and conveys to Assignee, subject to existing encumbrances, all of its right, title and interest in and to all letters patent of the United States or the equivalent thereof in any other country, all registrations thereof, and all applications for letters patent of the United States or the equivalent thereof in any other country, including registrations and pending applications in the United States Patent and Trademark Office or any similar offices in any other country set forth on Schedule A hereto, and all reissues, continuations, divisionals, continuations-in-part, certificates of reexamination, renewals or extensions thereof, together with the right to bring an action at law or in equity for any claims for damages by reason of past, current, or future infringement and/or provisional rights under said patents, with the right to sue for, and collect the same for its own use and behalf, and for the use and behalf of its successors, assigns, or other legal representatives. (the foregoing, collectively, "Assigned Patents"). Assignee shall hold all right, title and interest in and to the Assigned Patents as fully and exclusively as same would have been held and enjoyed by Assignor had the above assignment not been made.

2. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks, and any official of any country or countries foreign to the United States, whose duty is to issue patents or other evidence or forms of industrial property on applications as aforesaid, to issue any and all Letters Patents of the United States, or their foreign equivalent, on said inventions to Assignee or to such nominees as it may designate as assignee of the entire interest.

3. At Assignee's request and expense, Assignor will take such further actions and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to and rights in the Assigned Patents in

Assignee. Assignor hereby authorizes Assignee to request the relevant registrars, registries and government entities and offices to record this Assignment and take all other necessary and desirable actions to further the intents and purposes of the Assignment.

4. This Assignment shall be governed by and construed in accordance with the laws of the State of New York. Any dispute relating to this Assignment shall be resolved solely in the state or federal courts located in Manhattan, New York.
