PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT ("Assignment") made and effective this 10th day of October, 2019 ("Effective Date") by and between GETGO, Inc. ("Assignor"), a Delaware corporation having a usual place of business at 333 Summer Street, Boston, MA 02210, and LogMeIn, Inc. ("Assignee"), a Delaware corporation having a usual place of business at 333 Summer Street, Boston, MA 02210.

WHEREAS Assignor is the owner, or holder by prior assignment, of those particular patents and patent applications (collectively, the "Properties") listed on Schedule A to this Assignment; and

WHEREAS Assignor wishes to assign to Assignee the Properties together with those certain other Rights (as defined below) associated with and/or related to the Properties; and

WHEREAS Assignee wishes to accept assignment of the Properties and the Rights, all subject to the provisions of this Assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. As used in this Assignment, the term "Rights" means, with respect to the inventions disclosed in the Properties ("Inventions"), any and all: (a) rights anywhere in the world to the Inventions; (b) Letters Patent that have issued or may subsequently issue; (c) patent applications, including but not limited to provisionals, non-provisionals, continuations, continuations-in-part, divisionals, reissues, reexaminations, extensions, and substitutions of the Properties; (d) right, title, and interest Assignor may have in provisional and non-provisional applications to which the Properties claim priority, including without limitation any rights arising under any international convention concerning patents; and (e) any and all rights of action and recovery for infringement of the Properties, including infringement that occurred prior to this Assignment. All Rights are to appertain to Assignee as fully and entirely as any of the same would have been held and enjoyed by Assignor had this Assignment not been entered into between Assignor and Assignee.
2. Assignor by these presents does hereby, as of the Effective Date, assign and transfer to Assignee, its successors, assigns, and legal representatives Assignor's entire right, title, and interest in and to the Properties and the Rights throughout the world.
3. Assignee hereby accepts from Assignor the assignment of the Properties and the Rights, as of the Effective Date.
4. As of the Effective Date and to the extent not addressed by the other express terms of this Assignment, Assignor by these presents does assign and transfer to Assignee all of the Assignor's rights to the Inventions arising under or pursuant to any and all United States laws, foreign laws, or international agreements, treaties, or laws relating to the protection of industrial property, including without limitation the right to file any applications for Letters

Patent as well as the right to any causes of action and damages accruing prior to their Assignment.

5. Assignor hereby acknowledges that this Assignment includes without limitation the right in Assignee to apply for and obtain from competent authorities in all countries of the world any and all Letters Patent by attorneys and agents of Assignee's selection and the right to procure the grant of all Letters Patent to Assignee in its own name.
6. Assignor hereby further agrees, to carry out in good faith the intent and purpose of this Assignment, to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary or desirable to secure fully the Rights to Assignee, its successors, assigns, and legal representatives. Without limiting the generality of the preceding sentence, Assignor agrees to (a) execute applications for patents in any country or countries; (b) execute substitution, reissue, divisional, or continuation applications and preliminary or other statements in any such country or countries; and (c) give testimony in any interference or other proceeding in which the Inventions or any application or patent directed thereto may be involved. The cost of all activities undertaken by Assignor further to the provisions of this section shall be borne by Assignee and/or its successors, assigns, and/or legal representatives.
7. Assignor by these presents hereby warrants and covenants that no assignment, grant, mortgage, license, or other agreement affecting the Properties or the Rights conveyed has been or will be made to any other party and that the full right to convey the same is possessed by Assignor.
8. Assignor by these presents hereby authorizes and requests the Director of the United States Patent and Trademark Office and the empowered officials of all other governments to issue such Letters Patent as shall be granted upon applications to Assignee, its successors, assigns, and/or legal representatives.
9. This Assignment shall be binding upon and inure to the benefit of Assignor, and its respective successors and assigns. This instrument shall not confer any rights or remedies upon any third party.
10. This Assignment sets forth the entire understanding and agreement, whether written or oral, between Assignor and Assignee with respect to the matters set forth in this Assignment.
11. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original and all of which together shall constitute one assignment with the same effect as if the parties had signed the same signature page.

IN WITNESS WHEREOF, the parties have caused this Assignment to be executed by their duly authorized officers to be effective as of the Effective Date; *provided, however*, that this Assignment shall not become effective as to either party until executed on behalf of both parties.

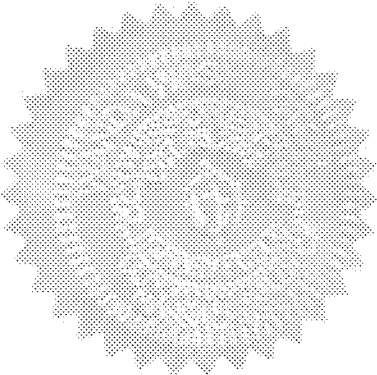
