
We hereby request the Commissioner for Patents to issue the Design Patent in accordance with this instrument;

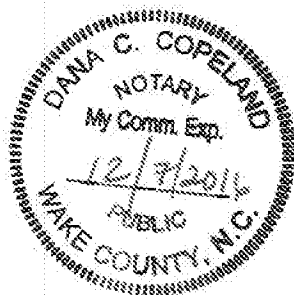

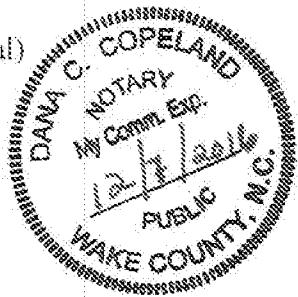
