**RELEASE OF SECOND LIEN SECURITY INTEREST
IN PATENTS**

This RELEASE OF SECOND LIEN SECURITY INTEREST IN PATENTS, dated as of October 16, 2019 (this “**Release**”), is made by UBS AG, Stamford Branch, acting through one or more of its branches or any Affiliate thereof, as collateral agent for the Secured Parties (the “**Collateral Agent**”) in favor of DigiCert, Inc. and Geotrust, LLC (each a “**Grantor**,” and collectively the “**Grantors**”). Capitalized terms used in this Release and not otherwise defined herein have the meanings ascribed to them (explicitly or by reference) in the Patent Security Agreement (as defined below).

WHEREAS, Grantors, the Collateral Agent and the other parties thereto executed and delivered that certain Second Lien Security Agreement dated October 31, 2017 (as may have been amended, amended and restated, supplemented or otherwise modified, the “**Security Agreement**”);

WHEREAS, pursuant to the terms of the Security Agreement, Grantors executed and delivered that certain Second Lien Patent Security Agreement, dated October 31, 2017 (the “**Patent Security Agreement**”), which was recorded with the United States Patent and Trademark Office on November 3, 2017, at Reel/Frame No. 44710/0529;

WHEREAS, pursuant to the Security Agreement and the Patent Security Agreement, each Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in all of such Grantor’s right, title and interest in and to the following, except for any Excluded Property: (i) the patents and patent applications set forth in Schedule A hereto; (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; (iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and (iv) any and all proceeds of, collateral for, income, royalties and other payments then or thereafter due and payable with respect to, and supporting obligations relating to, any and all of the foregoing collateral of or arising from any of the foregoing (the “**Patent Collateral**”); and

WHEREAS, Grantors have requested the Collateral Agent to, and the Collateral Agent now desires to, terminate and release its security interest in the Patent Collateral.

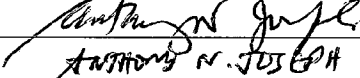
NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without recourse, representation, warranty, promise, undertaking, statement or assurance of any kind or nature, and at the Grantors’ sole cost and expense, hereby terminates, cancels and releases its security interest in the Patent Collateral, and hereby reassigns to each Grantor any right, title or interest it may have in the Patent Collateral of such Grantor.

The Collateral Agent authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release at the Grantors' sole cost and expense.
