THIS ASSIGNMENT is made the 29th day of May 2019

BETWEEN

- (1) **LIDCO LIMITED** incorporated and registered in England and Wales with company number 02736561 whose registered office is 16 Orsman Road, London, N1 5QJ (the "Assignor"); and
- (2) **LIDCO GROUP PLC** incorporated and registered in England and Wales with company number 02659005 whose registered office is 16 Orsman Road, London, N1 5QJ (the "Assignee").

BACKGROUND

The Assignor has agreed to assign to the Assignee its rights in two patent applications ("the Applications"), further particulars of which are given in the Schedule, in respect of the Invention(s) disclosed in the Applications ("the Invention") together with know-how associated with the Invention ("Know-how") and all their right, title and interest therein upon the terms and conditions set out below.

OPERATIVE PROVISIONS

1. In consideration of the sum of £1 paid by the Assignee to the Assignor (the receipt and sufficiency of which the Assignor hereby acknowledges) the Assignor with full title guarantee **HEREBY ASSIGNS** to the Assignee:
 - (a) all the rights of the Assignor in and to the Invention, the Application and the Know-how and the full and exclusive benefit of them and all rights privileges and advantages associated with them;
 - (b) the full right to apply for and obtain patents or other similar forms of protection in respect of the Invention throughout the world;

- (c) the right to make any new application or applications anywhere in the world in respect of any part or parts of the subject matter of any application or specification filed in connection with the Invention;
- (d) any patents or other similar forms of protection granted in respect of the Inventions pursuant to the Applications;
- (e) the right to claim priority of the Applications; and
- (f) the right to bring proceedings (anywhere in the world) for the recovery of damages and/or other remedies in respect of any previous infringement of the rights assigned by this Assignment.

TO HOLD the same unto the Assignee absolutely.

2. The Assignor hereby covenants with the Assignee that it shall execute such further documents and do such further acts as may reasonably be required by the Assignee to enable the Assignee (or its nominee) to enjoy the full benefit of the property and rights hereby assigned and to apply for any patents or other forms of protection in respect of the Invention or the Know-how throughout the world, and fully and effectively to vest the same in the Assignee or as the Assignee shall direct.
3. The Assignor further covenants with the Assignee that at the request and expense of the Assignee it shall provide all such assistance as the Assignee may reasonably require in connection with any proceedings concerning the Know-how, the Applications or any patents, patent applications or similar rights applied for or arising in respect of the Invention, including the disclosure of relevant documents and materials and the provision of oral and written testimony from relevant personnel.
4. This Assignment shall be governed by and construed in accordance with English law and shall be subject to the exclusive jurisdiction of the English courts.
