ASSIGNOR hereby covenants that ASSIGNOR has full right to convey ASSIGNOR'S entire right, title and interest in said invention and that that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement.

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application(s),

invention and Letters Patent and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application(s), invention and Letters Patent and legal equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.

As this assignment to the above referenced invention may be executed in advance of the filing of a patent application, ASSIGNOR hereby authorizes the legal representative of the above-mentioned ASSIGNEE to insert in this instrument the filing date and serial number of said application, when known, or any other information that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
