FURTHER ASSURANCES: The Parties must each sign all further documents, pass all resolutions and do all further things as may be necessary or desirable to give effect to this Assignment.

AMENDMENTS: This Assignment may only be amended by agreement of the Parties in writing.

WAIVER: No exercise or failure to exercise or delay in exercising any right or remedy will constitute a waiver by that party of that or any other right or remedy available to it.

SEVERABILITY: The invalidity, illegality or unenforceability of any provisions of this Assignment will not affect the continuation in force of the remainder of this Assignment.

COSTS: Except as otherwise provided in this Assignment, the Parties will meet their own costs relating to the negotiation, preparation and implementation of this Assignment.

COUNTERPARTS: This Assignment may be signed in any number of counterpart copies which, read together, will constitute one and the same document. Such signed counterpart copies may be exchanged between the Parties by facsimile, email or otherwise.

LAW AND JURISDICTION: This Assignment and any disputes arising from or connected with this Assignment shall be subject to the laws of New Zealand. The Parties submit to the non-exclusive jurisdiction of the Courts of New Zealand.
