8. INVENTOR acknowledge and understand that they have had the opportunity to consult with independent legal counsel prior to executing this Assignment.

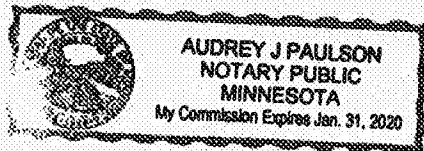


