
RELEASE OF SECURITY AGREEMENT

WHEREAS, East West Bank, having an address at 2350 Mission College Blvd., Suite 988, Santa Clara, CA 95054 ("the Secured Party"), and Cervel Neurotech, Inc., which had an address of 1164 Triton Drive, Suite 200, Foster City, CA 94404 (the "Grantor"), have entered into an Intellectual Property Security Agreement (the "Security Agreement") as of April 12, 2013, which Security Agreement has been recorded at the U.S. Patent and Trademark Office on April 23, 2013, at Reel 030285, Frame 0863, with respect to, inter alia, US patent applications no. 12/670,938, 12/838,299 and 13/169,967, as well as US patent no. 8,267,850 (hereinafter "Patent Properties"); and

WHEREAS, The Secured Party entered into a Security Interest Termination Agreement with Rio Grande Neurosciences, Inc., on July 17, 2015 (the "Security Termination Agreement"), which released the Secured Party's security interest in assets that included the Patent Properties and terminated the Security Agreement.

NOW THEREFORE, for the purpose of the recordation in the U.S. Patent and Trademark Office of the release of the security interest of the Secured Party that was formalized in the Security Interest Termination Agreement, without the necessity of recording original documents that may contain confidential information, the Secured Party hereby confirms its release of the Patent Properties from the Security Agreement, effective, nunc pro tunc, as of July 17, 2015.
