

OF

CONVERTRO, INC.  
(a Delaware Corporation)

INTO

AOL ADVERTISING INC.  
(a Maryland corporation)

Pursuant to Title 8, §252 and §103 of the General Corporation Law of the State of Delaware ("DGCL"), the undersigned corporation executed the following Certificate of Merger:

FIRST: AOL Advertising Inc., a Maryland corporation with its principal office at 770 Broadway, New York, NY 10003 and Convertro, Inc., a Delaware corporation, incorporated under the General Corporations Law of the State of Delaware on June 22, 2009, with its principal office at 301 Arizona Avenue, Suite 400, Santa Monica CA 90401 have agreed to merge.

SECOND: An Agreement of Merger by and between AOL Advertising Inc. and Convertro, Inc. (the "Agreement") dated as of March 27, 2015, has been duly, approved, adopted, certified, executed, and acknowledged by each of the constituent entities in the manner and by the vote required by its charter and the laws of the place where it is organized.

THIRD: The name of the surviving corporation is AOL Advertising Inc., a Maryland corporation.

FOURTH: The Agreement provides for, among other things, the merger of Convertro, Inc. with and into AOL Advertising Inc. pursuant to which all shares of capital stock of Convertro, Inc. shall be cancelled.

FIFTH: The Articles of Association of AOL Advertising Inc. shall be the articles of association of the surviving corporation.

SIXTH: The merger is to become effective on April 1, 2015.

SEVENTH: The Agreement of Merger is on file at 22000 AOL Way, Dulles, Virginia, 20166, a place of business of the surviving corporation.


EIGHTH: A copy of the Agreement of Merger will be furnished by the surviving corporation, on request and without cost, to any shareholder of the constituent entities.
