TERMINATION OF SECURITY INTEREST
IN PATENTS

THIS TERMINATION OF SECURITY INTEREST IN PATENTS is made effective as of November 6, 2019 (the "Effective Date") by CIBC Bank USA (formerly known as The PrivateBank and Trust Company), as administrative agent (the "Administrative Agent") in favor of BrandFX, LLC, a Delaware limited liability company (the "Grantor").

The Administrative Agent hereby terminates, releases, discharges and disclaims, on a nonrecourse basis and without any representation or warranty, any Lien, security interest, pledge and/or assignment in each case created in its favor by Grantor in: the Patent Collateral, including each patent and patent application referred to in Schedule A attached hereto, together with any reissues, reexaminations, certificates, continuations, continuations-in-part, divisionals, or extensions thereof; each patent license of any of the Patent Collateral; and including all products and proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement of any of the Patent Collateral.
