SECURITY INTEREST AGREEMENT

In consideration of Ten Dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned, New NSI Holdings, Inc., a corporation organized under the laws of the State of Delaware, having a mailing address c/o Summit Plastic Company, 3175 Gilchrist Road, Mogadore, Ohio 44260 ("Grantor"), **DOES HEREBY:**

Grant to Costa Farms, LLC (the "Secured Party") a continuing security interest in and to all of Grantor's right, title and interest in and to the following patent:

- U.S. Patent No. 8,627,599, entitled "PLANTING POT DISPLAY SYSTEM" filed September 22, 2010, issued January 14, 2014 (hereinafter the '599 Patent)

for the purpose of securing the obligations contained in a certain Promissory Note dated as of June 11, 2019 between Grantor and the Secured Party (the "Note"); and does hereby

Collaterally assign and grant to the Secured Party a security interest in and to the entire right, title and interest of and in the '599 Patent and the inventions disclosed therein.

Covenant with said Secured Party, its successors and assigns, that the full right to convey the interests as herein expressed is possessed by Grantor, and except for liens granted to the existing lenders to Grantor, no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by Grantor.

Authorize the Secured Party to file any and all financing statements, continuation statements or any other filings and to provide any notices as may be required to perfect the Security Interest pursuant to the Uniform Commercial Code and/or the Patent Act.

Upon payment in full of the Note, the liens and security interests granted hereunder shall be released by Grantor.
