
PATENT ASSIGNMENT

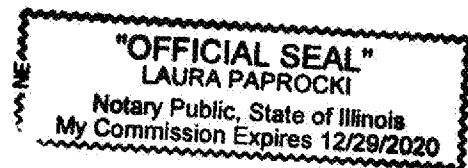
