**RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this “**Release**”) is given as of November 8, 2019 to WS Acquisition, LLC, an Oregon limited liability company (the “**Company**”), by Fifth Third Bank, successor in interest to MB Financial Bank, N.A., successor in interest to Cole Taylor Bank (“**Lender**”). WHEREAS, Company and Lender entered into that certain Grant of Security Interest in Trademarks and Patents dated as of January 31, 2013 (the “**Security Agreement**”) pursuant to which Company granted to Lender a security interest in, and a lien on, certain Marks and Patents, including, without limitation, Company’s grant to Lender of a security interest, and a lien on the trademarks identified on Exhibit A to this Release and the patents identified on Exhibit B to this Release; and

WHEREAS, Company has requested that Lender release its security interest in and liens upon the Marks and Patents.


