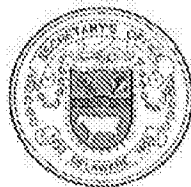

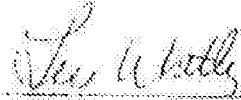
CERTIFICATE OF FORMATION
