AND WE HEREBY covenant that We have full right to convey the entire interest herein assigned, and that We have not executed, and will not execute, any agreement in conflict herewith;


AND WE HEREBY further covenant and agree that We will communicate to **The Research Foundation for the State University of New York**, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all non-provisionals, divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the **The Research Foundation for the State University of New York**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries;

AND WE HEREBY grant Heslin Rothenberg Farley & Mesiti P.C. the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.


