WHEREAS BB UK wishes to confirm that ASSIGNEE is the owner of all rights, title and interest of the ASSIGNOR, including all rights, title and interest that BB UK may possess, in and to the Creations, Creation Documents, and/or Applications, inclusive of any and all priority rights derived therefrom, and all ancillary rights relating thereto, as listed in "Schedule A" attached hereto; and
