AND, Assignor hereby authorizes and requests the Commissioner of Patents of the United States and any official of any foreign jurisdiction whose duty it is to issue patents, to issue any and all letters patents of the United States or such foreign jurisdiction granted upon the inventions set forth in the Application to Assignee, and hereby covenants that it has full right to convey its entire interest as herein assigned, and that it has not executed any agreement inconsistent herewith and will not execute any agreement inconsistent herewith without Assignee’s consent;




