Davis, hereby covenant and agree that I am the owner of the full title herein assigned and have the right to assign the same, and agree that I will communicate to said Elizabeth Kemp and Safe Medical Technology or their representatives any facts known to me respecting said invention and testify in any legal proceedings relating thereto when called upon, and will sign all instruments and documents and render such assistance which, in the judgment of Elizabeth Kemp and Safe Medical Technology is necessary to vest and protect the legal title sought to be assigned to it.
