- (d) said PCT International Application: PCT International Application No.: PCT/US2017/021954 filed on March 10, 2017;
- (e) any United States or corresponding foreign, regional (including any patent application filed with the European Patent Office) or international patent application claiming or applied for (now or in the future) the Inventions, or claiming priority to, or the benefit of the filing date of, (now or in the future) the Invention or any corresponding U.S., foreign, regional, or international application (including any PCT applications) related and directed to the Inventions, including all divisions, continuations, continuations-in-part and substitutions thereof; and
