RELEASE OF SECURITY INTEREST

Reference is made to that certain Secured Convertible Promissory Note dated July 31, 2018 (the "Note") issued by Insight Photonic Solutions, Inc., a Delaware corporation (the "Borrower") to Deeptech Disruptive Growth Investments LTD, a United Kingdom corporation (the "Lender"). For valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Lender hereby irrevocably terminates, forever releases and discharges the Lender's security interest and liens granted pursuant to the Note in the Borrower's Collateral.

The Lender will deliver to the Borrower UCC-3 financing statement amendments and such other instruments of release and discharge pertaining to the security interests and liens described herein of the Lender in the Collateral as the Borrower may reasonably request to effectuate, or reflect of public record, the release and discharge of all such security interests and liens in the Collateral. In addition, the Lender hereby authorizes the Borrower and its officers, counsel and other designees from and after date hereof, to file all Uniform Commercial Code or similar financing statement amendments as are desirable or necessary to effectuate, or reflect of public record, the release and discharge of such security interests and liens in the Collateral.


