**LAST WILL AND TESTAMENT**

**OF**

**LAWRENCE KNAPP**

BE IT REMEMBERED that I, Lawrence Knapp of Lynn, County of Essex, in the Commonwealth of Massachusetts, being of full age, unmarried, and of sound and disposing mind and memory, but knowing the uncertainty of this life, do make this my LAST WILL AND TESTAMENT, hereby revoking any and all former wills and codicils previously made by me.

FIRST, I nominate and appoint my brother, Michael Knapp of Lafarge, Vernon County, Wisconsin, to be my Personal Representative of this my LAST WILL AND TESTAMENT and of my estate.

SECOND, in the event that Michael Knapp should for any reason fail to qualify, or having qualified, fail to complete the administration of my estate, I nominate and appoint my son, Samuel Knapp of Verona, Allegheny County, Pennsylvania, as the alternative Personal Representative, with all the rights and powers of his predecessor.

THIRD, and in addition to any and all other lawful powers

of a Personal Representative in the administration of my estate, I hereby authorize and empower the said Michael Knapp, or Samuel Knapp acting as the alternative Personal Representative, to take immediate possession of both my personal and real estate, if any; to collect the rents, if any; and to forthwith sell and convey the same for such cash consideration as he alone may deem advisable and proper. Such power may be exercised with or without notice, and without the order or permission of the court therefore, and no purchaser shall be required to be responsible for the application or disposition of the consideration paid to the Personal Representative or to his successor.

FOURTH, I request that any person appointed to serve as Personal Representative, or successor or alternative hereunder, shall be exempt from giving any bond, or, if required to give bond, shall be exempt from furnishing any surety.

FIFTH, after the payment of my just debts and funeral expenses, which charges and expenses I authorize and direct my Personal Representative to pay, I give, devise, and bequeath as follows:

a. I give, devise, and bequeath the contents of any and all of my personal bank accounts, and any personal and household items I may own at the time of my death, to my son Samuel Knapp.

b. I give, devise, and bequeath all shares of, and business assets regarding my business named Knapp Made Products, Inc. to my brother Michael Knapp.

c. I give the rest and residue of my estate, and all personal property not previously listed, to my son Samuel Knapp.

SIXTH, Any and all decisions, determinations or actions made or taken in good faith by the Personal Representative pursuant to the powers and discretions given in this Will shall be conclusive on all persons who are or may become interested in my estate under this Will.

SEVENTH, Insofar as I have failed to provide in this Will for anyone, such failure is intentional and not occasioned by accident or mistake.






