PATENT ASSIGNMENT

WHEREAS, WE, Scott R. Fisher, a citizen of the United States, residing at 8965 Heather Ann Drive, West Chester, OH 45069; Alan F. Griffiths, a citizen of the United States, residing at 6684 Old Station Drive, West Chester, OH 45069; Daniel C. Cambron, a citizen of the United States, residing at 467 Ashland Terrace, Lexington, KY 40502; and Matthew K. Caskey, a citizen of the United States, residing at 1727 Clark Drive, Loveland, OH 45140 (hereinafter referred to as "ASSIGNORS"), have invented an IMPROVED ELECTRONIC LOCKBOX, for which we have executed an application for Letters Patent of the United States, of even date herewith, or under S/N 62/824,494, and

WHEREAS, SentiLock, LLC, a limited liability company duly organized and existing under the laws of Ohio, having its principal place of business at 7701 Service Center Drive, Cincinnati, Ohio 45069 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the entire interest therein:

TO BE HELD AND ENJOYED by said ASSIGNEE, its successors, and assigns, to the full ends of the respective terms for which said patents have been or may be granted, as fully and entirely as the same would have been held and enjoyed by us, had no sale and assignment of said interest been made.

EACH ASSIGNOR, individually, STATES the following:

As a named INVENTOR, I HEREBY DECLARE that: (a) the above-identified patent application was made or authorized to be made by me, (b) I believe that I am the original inventor or an original

ASSIGNORS HEREBY further covenant and agree that we will: communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting said Invention, and testify in any legal proceeding; sign all lawful future documents, including assignments in favor of ASSIGNEE, or its designees, as ASSIGNEE or its designee may from time-to-time present to me in order to perfect title in said Invention; execute all divisional, continuing, continuation-in-part, reissue, reexamination, renewal, and foreign applications in any country; and make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said Invention in all countries.
