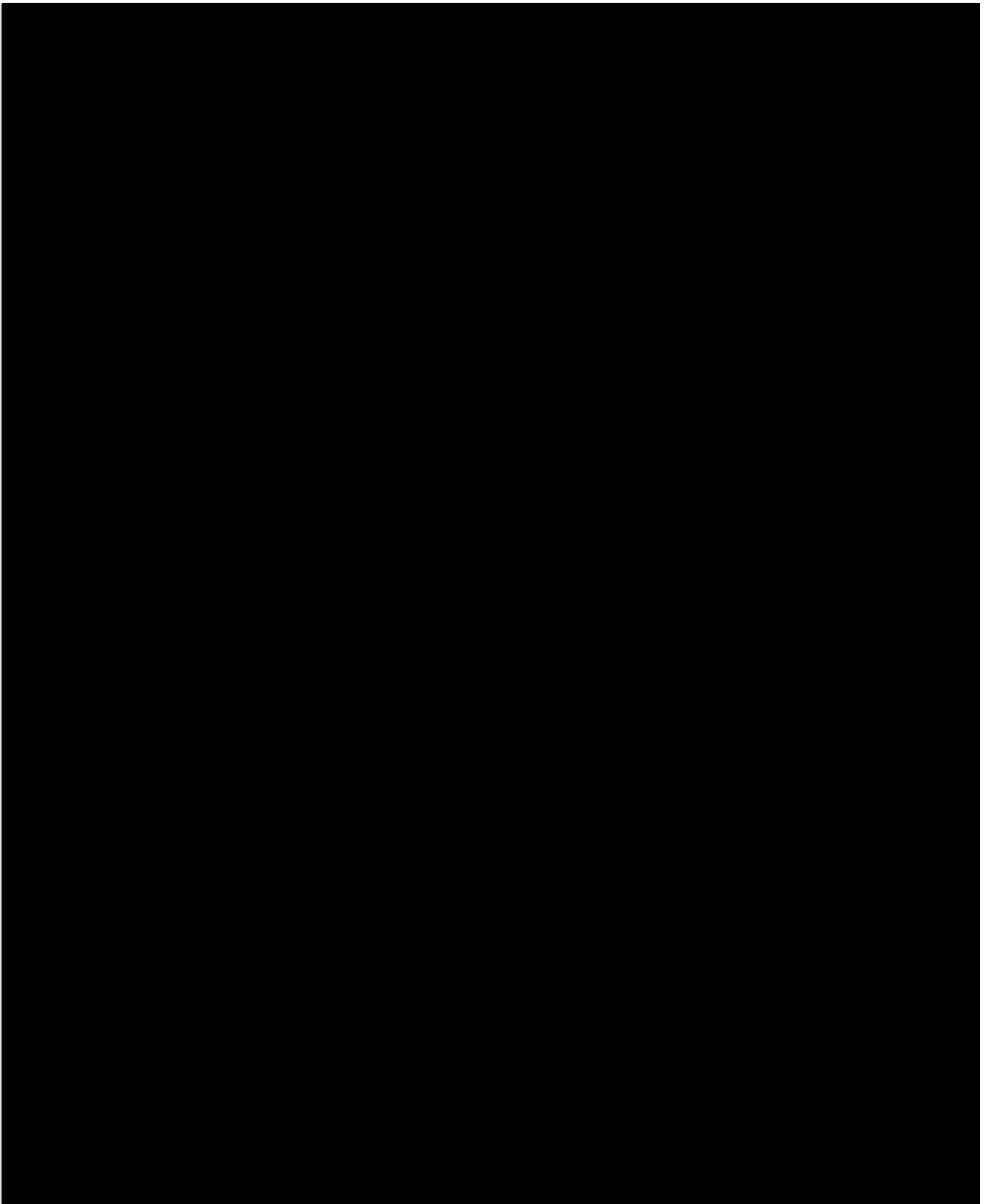
## 2. GRANT
