ASSIGNMENT

THIS ASSIGNMENT is made BETWEEN

AND

3. HAMILTON SUNDSTRAND CORPORATION, a US corporation of Four Coliseum Centre, 2730 West Tyvola Road, Charlotte NC North Carolina 28217-4578, United States of America ("HAMILTON SUNDSTRAND")

WHEREAS

- A. The INVENTORS are the inventors of certain invention(s) ("the Invention(s)") described and claimed in European patent application No. 19461552.2 entitled "Heat Exchanger" and filed on 2 July 2019, in the name of UTC AEROSPACE SYSTEMS WROCLAW SP. Z O.O., ("the Patent Application")

- (ii) The right to claim priority under any national, regional or international law or treaty from the Patent Application or from any other Application for intellectual property rights in respect of the Invention(s)
- (iii) The right, title and interest in the Patent Application and any patent granted in consequence thereof including the right to sue for damages and other remedies in respect of any infringement of said patent

TO HOLD the same unto HAMILTON SUNDSTRAND absolutely

2.
