(a) the Inventions and all rights in each and every state, country, and region throughout the world to patents and all other industrial or intellectual property rights arising from having made or discovered the Inventions;

(b) all divisions, continuations, substitutions, and registrations of the Applications, all other applications that claim any of the Inventions, and all grants of patent (including utility patents, patents of addition, utility models, designs, and corresponding registration rights) issuing from any from any of the foregoing applications, and all reissues, renewals and extensions thereof; and

(c) all rights to claim priority under any and all treaties and conventions, including the Paris Convention for the Protection of Industrial Property, arising from applications for patent on the Inventions, each of the Applications, and all divisions, continuations or substitutions thereof;

the same to be held and enjoyed by ELFA, its assigns and successors, as fully and entirely as the same would have been held and enjoyed by us, had this Assignment not been made.

We will, at any time upon the request and at the expense of ELFA, execute and deliver any and all papers and do all lawful and reasonable acts that may be necessary or desirable, in the opinion of ELFA, to enable and assist ELFA at its expense to (a) obtain patents, both domestic and foreign, on the Inventions, including without limitation execution of assignments of applications and priority rights and powers of attorney; (b) establish, maintain and secure title in ELFA, its successors and assigns, to the foregoing, including making such title of lawful public record; and (c) defend, establish or otherwise preserve the validity of said patents against any and all infringers, and perform such other acts as are necessary to give full force and effect to the foregoing assignment.

We represent and covenant that no assignment, mortgage, sale, license, pledge, encumbrance or alienation of the Inventions, the Applications, or any other right assigned hereunder, has been or will be made or entered into which would conflict with the assignment thereof to ELFA.


