COVENANT, when requested and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment, to execute all divisional, continuing, substitute, renewal, reissue, and all other applications for patents or their legal equivalents relating to any and all of the Improvements; to execute all rightful oaths, declarations, powers of attorney, assignments, and other papers; to communicate to the ASSIGNEE all facts and provide to the ASSIGNEE all documents and things known and accessible to the ASSIGNOR relating to the Intellectual Property Rights, including, but not limited to, the Improvements, the '915 Application, the Related Applications, and the histories thereof, and to testify as to the same in any interference, derivation, or review proceeding, litigation, or other proceeding relating to the any of the Intellectual Property Rights, including, but not limited to, any of the Improvements, the '915 Application and any Related Application, and/or the history of any of the foregoing, and generally to do everything possible which the ASSIGNEE shall consider desirable for vesting

title to all of the Intellectual Property Rights in the ASSIGNEE, and to secure, maintain, defend, and enforce valid and enforceable patent protection for the Improvements;
