ASSIGNMENT AGREEMENT

Between

SANTEN

A simplified joint stock company with a sole shareholder (« société par actions simplifiée à associé unique ») incorporated under the laws of France and registered in the Trade and Companies Registry under number RCS Evry 432 584 225 with its registered head offices at 1 rue Pierre Fontaine, Bâtiment Genavenir IV, 91000 Evry, France

hereinafter designated as "Santen"

and

ARCADOPHTA

A limited liability company ("société à responsabilité limitée") incorporated under the laws of France and registered in the Trade and Companies Registry under number RCS Toulouse 440 530 558 with its registered head offices at 11 rue Antoine Ricord, 31100 Toulouse, France

hereinafter designated as "Arcadophta".

Santen and Arcadophta may also be hereinafter designated individually as a "Party" and collectively as the "Parties"

WHEREAS:

Santen is the holder of the patents set out in the attached Schedule ("Contract Patents"). The Parties have entered into a Patent Purchase and Patent Transfer Agreement by which Arcadophta acquires the Contract Patents. Santen has agreed to transfer the Contract Patents to Arcadophta and to execute the necessary document in order to enable Arcadophta to apply for the change of ownership in the Contract Patent.


NOW THIS AGREEMENT WITNESSES:

1. For good and valuable consideration, the sufficiency and receipt of which Santen hereby acknowledges, Santen hereby assigns, transfers and sets over with effect from the date of this Agreement all the right, title and interest of Santen in and to the Contract Patents to the Arcadophta together with all claims, demands, causes of action and rights of action for infringement or otherwise accrued or accruing and all rights to costs, damages, profits, penalties and all other relief in respect thereof.


2. This Agreement shall be used in order to register the transfer of ownership and may be presented by Arcadophta to any relevant Office. Santen agrees to execute all further documents to enable Arcadophta to apply for and obtain registration as the holder of the Contract Patent and, at the expense of the Arcadophta, to execute all documents and render all assistance reasonably required by the Arcadophta for the purposes of confirming the Arcadophta's title to the Contract Patent.
3. **General**
- a) Any change or amendment of this Agreement shall require written form. This shall also apply for changes to the written form requirement itself.
 - b) Unless otherwise agreed, the terms and provisions of the Patent Purchase and Patent Transfer Agreement concluded between the Parties apply.
 - c) This Agreement may be executed in any number of counterparts. All counterparts together will be taken to constitute one instrument.




